To make your time more enjoyable with **Austin Party Shuttle = ( APS )**, we ask your cooperation with the following:  
Service time will start when the bus arrives at the pick-up location and end when the last passenger is dropped off. If your event exceeds the agreed time, the renter will be charged the agreed upon hourly rate for every hour your event exceeds. **APS** enforces State and Federal Laws and will uphold a zero tolerance policy that no drugs will be used on the bus. Drug violators will be asked off of the bus with no refund for time used. All law enforcement agencies have the right to stop any of **APS** busses and conduct administrative searches. The purchaser will be held responsible for any minors found drinking alcoholic beverages on any of Austin Party Shuttle. Any use of illegal drugs or any other illegal activity will result in the chauffeur immediately stopping and termination of the ride with no refund.

**Austin Party Shuttle WILL NOT BE RESPONSABLE FOR ANY INJURIES no matter who is at fault, caused by alcohol intoxication, roughhousing, fighting, or any other self/passenger related injuries while vehicle is in motion, at a standstill or entering and exiting the bus. Austin Party Shuttle drivers reserve the right to have any passengers vandalizing an Austin Party Shuttle bus to exit the bus with no refund. This includes jumping on seats, hanging on ceiling hand rails. The purchaser on this contract is responsible for each of his or her guests and of their actions.**

**AT THE DRIVERS DISCRETION, PURCHASER AGREES TO BE FULLY LIABLE FOR ALL CHARGES THAT MAY INCUR.**

- 2. \$150.00 DETAILING AND WAXING (DUE TO SICKNESS)**
- 3. \$250.00 SHAMPOO AND DISINFECT (DUE TO SICKNESS - INTERIOR)**
- 4. \$300.00 MINIMUM PER EACH BURN HOLE, RIP OR TEAR TO UPHOLSTERY OR BREAKAGE OF ELECTRONICS**
- 5. \$175 FOR EACH ACT OF VANDALISM**

**Austin Party Shuttle = (APS)** reserves the right to terminate this or any other contract for noncompliance of the above request especially if renters do not follow chauffeurs request in order to obey the rules in the contract. **No smoking is allowed in our vehicles. All deposits (cash or credit card authorization) are nonrefundable. APS requires \$ 150.00 security deposit. Deposits are held in order to secure your party bus reservation.** You can cancel but we need one week notice prior to reserved date. You can reschedule your reservation at a later date but no more than two months past the original reserve date. (Please keep in mind to reschedule 3 weeks in advance) The authorized card holder for the given credit card is responsible for the payment of the total amount, via cash, credit card, or square wallet. As with all contracts, all of the given information for the renter is binding and cannot be changed without **APS** acceptance. If the contract is canceled after it is signed. **APS** is still authorized to collect the remaining balance in full, if the bus was not re-rented again on the cancel date for the same or higher amount. We will reserve the said date upon the approval of the purchaser's credit as per telephone conversation. The credit card holder gives authorization to use the credit card information over the phone/internet in combination with signed contract. At time of the pickup we need the actual credit card and state identification of the purchaser that authorized the transaction of the signed contract, **APS** Cannot guarantee the actual credit and the state identification of the purchaser that authorized the transaction of the signed contract, **APS** cannot guarantee the availability of overtime use. **Transfer jobs are priced for immediate pickup/drop off, 10 minute wait time is included. If customer fails to show at designated pick up location and does not inform office and or driver, the full amount of the contracted time will be charged. The purchaser authorized APS to charge any additional charges after they rendered services to the purchasers' credit card for supplemental charges. A 20% service fee (gratuity) will be added to your remainder of final bill, for the driver.** If cash payment is selected, the payment is due at the time of the beginning of the rental. Customer agrees to have **APS** to get the authorization for the above credit card and the amount, for the event stated above. **APS is not responsible for any delays before or during renter's reserved time caused by traffic conditions; mechanical failures, weather, or automobile accidents caused by others, or situations out of our control, and a refund will not be issued. In the event of a breakdown during your reservation, APS reserves the right to subcontract to another company to finish at your service agreement. Time loss during this will be refunded by hours or credited to future reserved booking. I am satisfied with the terms and conditions above and fully understand and agree.
